

COOKIE POLICY

The purpose of this policy

According to Section 155 (4) of Act C of 2003 on Electronic Communications, information may be stored or accessed on the electronic communication terminal equipment of a subscriber or user only upon the user's or subscriber's prior consent granted in possession of clear and comprehensive information about the implications.

Further, as per Article 6 of Regulation (EU) 2016/679 of the European Parliament and of the Council ("GDPR"), a valid legal basis is necessary for the processing of personal information.

The purpose of this policy is to provide you with the necessary information regarding our use of cookies and the storage of such cookies on your device when you access our site.

Basic concepts that help you understand this policy

What is personal data?

Personal data can be any data or information based on which a natural person can be directly or indirectly identified. For example, an IP address can qualify as personal data, because under certain circumstances it allows the identification of the user accessing a website from the given IP address.

What is data processing?

Data processing means all actions performed on personal data, including, among others, the collection, storage or deletion of personal data (e.g. gathering IP addresses).

What is a data controller?

The data controller is the entity (usually a company) responsible for specifying the purpose and means of data processing. In the case of essential cookies (see below), the controller of your data is Almotive Informatikai Korlátolt Felelősségű Társaság (seat: H-1025 Budapest, Szépvölgyi út 22.; company registry no.: 01-09-208016), while in the case of 3rd party cookies, the controller is the corresponding entity using the given cookie on our website.

What is a cookie?

A cookie is a small file of letters and numbers sent from our webserver that we store on your browser or the hard drive of your computer if you agree. Cookies contain information that is transferred to your computer's hard drive and are stored for a specific amount of time, depending on their type.

General information about our use of cookies

Cookies allow us to ensure the complete functionality of our websites, calculate the aggregate number of people visiting our websites and monitor the use of the websites. Cookies allow us to distinguish you from other users of our website, which helps us to provide you with a good experience when you browse our website and also allows us to improve our site. This helps us to improve our websites and better serve our users. We also use cookies that make the use of the website easier for you, for example by remembering usernames, passwords and (language) preferences. We also use tracking and analytics cookies to see how well our services are being received by our users.

Types of cookies used

Essential cookies. These are cookies that are required for the operation of our website. They include, for example, cookies that enable you to log into secure areas of our website.

Given that without these cookies some parts of our website would not function, we use them in order to be able to provide you with access to the full content of our website.

Analytical/performance cookies. They allow us to recognise and count the number of visitors and to see how visitors move around our website when they are using it. This helps us to improve the way our website works, for example, by ensuring that users are finding what they are looking for easily.

These cookies are used on the basis of your explicit and voluntary consent based on complete information provided by us in the form of this policy and our Privacy Policy (see below). You may withdraw your consent at any time by changing your cookie settings without costs and restrictions. The withdrawal of consent does not affect the lawfulness of data processing before the withdrawal. If you decide not to give your consent to the use of these cookies, or withdraw it at a later point, no analytical/performance data will be collected about your visit to our website.

You can manage cookies in your browser settings as well. However, if you use your browser settings to block all cookies (including essential cookies) you may not be able to access all or parts of our site.
